# Graduation Requirements MBA Program in International Management (imMBA) Fu Jen Catholic University

**Article I**: imMBA graduation requirements are listed as follows:

- 1. Complete 32 credits of required courses, including thesis, 0 credit.
- 2. Complete 10 credits of elective courses.
- 3. Pass master's thesis examination.
- 4. Minimum graduation credit is 42, including required courses, elective courses, and thesis.

## Article II: English proficiency requirement

- 1. TOEIC 750 or iBT TOEFL 71 or IELTS 6.0
- 2. Score of English proficiency test is only valid within 2 years prior to graduation.

# Students who don't meet the standard are required to do the following:

- 1. Take two English proficiency tests, TOEIC or iBT TOEFL or IELTS.
- 2. Take two imMBA approved English proficiency-enhancing courses and achieve scores of 70.
- 3. English proficiency-enhancing courses will not be counted towards graduation credits.

## Qualification to waive English proficiency requirement:

- 1. Once enrolled as a full-time student for at least 2 years at a university, not including language schools or courses, located in limited countries (see note) within 5 years prior to enrolling in imMBA.
- 2. It's compulsory to show valid proof of documentations, such as enrollment, transcripts, diploma, etc.

Note: US, UK, Ireland, Australia, New Zealand, Canada and South Africa

### **Article III**: Course registration

- Economics, Business Management, Statistics and Accounting are imMBA
  prerequisite courses. Students who did not take or failed these courses during
  their undergraduate studies need to complete and pass 1 of the aforementioned
  courses before the end of the first semester in the first year of enrollment. The
  chosen prerequisite course can't be counted towards graduation credits.
- 2. All graduate-level courses offered by other departments within College of Management can be recognized as elective credits.
- 3. Graduate-level courses offered by other Colleges can only be counted towards graduation credits with the consent from imMBA director before course registration.

- 4. Taiwan (ROC) students who choose non-English taught courses will only earn half of the credits (for example, only 2 credits will be received from a 4-credit course). Students of other nationalities are not subject to this limitation.
- 5. With the exception of the very last semester before graduation or the consent from imMBA director, all students in the first year need to take 9-18 credits per semester, and 8-18 credits per semester in the second year.

# **Article IV**: Prerequisites and procedures of master's thesis examination:

- 1. The prerequisite course and all required courses are passed, or in the process of completing during the semester of applying for master's thesis examination.
- 2. Minimum graduation credits are met.
- 3. English proficiency requirement is met. Its official hardcopy transcript needs to be submitted to imMBA office before applying for master's thesis examination.
- 4. To declare that the above information is true and correct, if not, students should bear all the responsibilities, including the result of master's thesis examination being invalid.
- 5. Master's thesis examination procedures are considered complete upon passing the master's thesis examination, finishing thesis revision with the advisor's endorsement, and submitting official result to the Office of Academic Affairs.
